
A passport, valid for a period of at least six months beyond the date of issuance of the visa and endorsed for travel to the United States by the issuing authority.

Tree color photographs for each visa applicant, including infants, regardless of age. The photographs must be color photographs with a white background. They must be glossy, unretouched and not mounted; the dimension of facial image should be about 1 inch from chin to top of hair; the subject should be shown in 3/4 frontal view showing right side of face with the right ear visible.

If you have difficulty in obtaining photographs to these specifications you may defer obtaining them until the time of your medical examination and formal interview as such photographs can be obtained in London.

Evidence of your former legal entry into the United States for permanent residence. Such evidence may take the form of an expired Re-Entry Permit (Form I-132); or an Alien Registration Receipt Card (Form I-151); or a stamp in your passport showing the date on which you were previously admitted into the United States as an alien resident, or other acceptable evidence to the same effect.

4. Police Certificates, in duplicate, are required from all applicants sixteen years of age or over, for every country in which you were physically present for six months or longer, since the time of your previous admission as an immigrant into the United States. Police Certificates are not obtainable nor required for residence in the United Kingdom. The Embassy will automatically obtain a police certificate in respect of your former residence in the United States. If you have only lived in the United States and the United Kingdom since your previous admission into the United States as an immigrant you do not need to obtain a police certificate.

- 5. Evidence, in duplicate, showing that you are not likely to become a public charge in the United States, as described in the enclosed OPTIONAL FORM 167 (formerly DSL-845).
- 6. If, since your admission into the United States, there has been any change in your marital status, documentary evidence in duplicate of such changes will be required.
- 7. Court Record, in duplicate, concerning any conviction other than for a minor traffic offense.

I understand that my (our) application for a visa cannot be accepted if I (we) fail to bring complete documentation at the time of my (our) appointment for medical examination and formal visa application.
